

Terms & Conditions

1. The promoter of the competition "Win a Postcard" is Postcards from V whose registered office is at Schleissheimer Strasse 280a, 80809 Munich, Germany.
2. Participation in the competition is exclusively subject to the conditions listed below. By participating in this competition, the participant accepts these terms and conditions.
